Other companies are required to maintain proper books of accounts but many waive an audit. The firm is able to provide full auditing services, as well as computerised accounting services.

Tax

There is no income or corporation tax in the Cayman Islands. The firm therefore liaises with the international tax experts in other Grant Thornton member firms in order to provide the best taxation advice to mutual clients.
