










OUR 2023 CONVENTION

The Convention was wrapped up with an entertaining Gala dinner and the Christmas party.











The impact of values on our life and organisational development

The latest Grant Thornton Convention in Milano Marittima provided an exceptional opportunity to meet up. They were three days of playing and sharing, addressing both current and across-the-board issues. but more than anything else a chance to meet, exchange views, strengthen and create relationships which, it has to be stressed, require physical contact and direct presence.

Why is it so important to find opportunities for in-person meetings?

It's worth noting that only 7% of communication is verbal, in other words based on the words we use. Communication is almost all para-verbal (the tone of voice) and based on proxemics, in other words on how our body interacts with people and the space around us.

Therefore, it's the body and not the words that do our communication for us.

Therefore, meeting in these situations is tantamount to getting to know each other, and creating spaces for even stronger relationships.

These events are extremely valuable as a way to reiterate the values and best practices on which Grant Thornton relies - because it is essential that our claimed values must be backed up by the values displayed by our actions, and therefore all those concrete actions that create well-being and development for oneself and for others.

During the Convention we focused on values and the kind of impact they have on our existence. It's worth going back over this issue - Why is it so important to identify one's value framework? Because it represents our guidance system, the compass that directs our choices and enables us to understand the meaning of our actions.

Values can be universal, such as joy, love or peace, or cultural - and are therefore reflected in our institutions and educational systems - but it's our Personal Values that shape our life and career choices.

How, therefore, can well-being and development be created?

By aligning organisational values and personal values.

If I'm aware of what guides my decisions then I can identify the values that apply to the "social bubble", meaning in this case the workplace that I'm immersed in for a large part of my day. I can reach my own decisions and tap into my aspirations and desires - which puts me in a position to be able to express them and create a virtuous cycle of communication with my colleagues and superiors, which can help me to make them come true.

Lastly, I can establish to what extent my personal inclinations are in tune with how the roles and projects are perceived within the organisational context, enabling me not only to understand the quantitative parameters linked to performance, but also, more importantly, the process by which one achieves the various goals.

The "how" then becomes an instance of everyone's core values and this is the most precious of assets. How can we hold on to it?

By being aware that we are all valuable contributors and that we are all responsible, each for his or her own part.

In every situation, but particularly in critical stages, we ask ourselves "What is within my power?" - but also - "What is my impact on the context, based on my role and my personal characteristics?". "How can I provide a valuable contribution, for myself and others?".

Acquiring a point of view certainly means taking responsibility for our scope of action but, upstream of this, it means referring to one's own personal power, that which makes us our aware of our amazing ability to deliver.




What inspired you to embark on this experience and why did you chose Barcelona?


